Note:

- The fees listed are in Singapore Dollars (SGD). Amount is subject to the prevailing Goods and Services Tax (GST) rate.
- All Singapore Citizens (SC), Singapore Permanent Residents (SPR), and alumni of NUS who are enrolled in this MSc programme will enjoy rebates* for the tuition fee. **These rebates will be automatically applied to the tuition fees, and eligible students do not need to apply for them. Similar to the tuition fee, rebates are also intake-based.**
- Rebates will not be applicable to SC/SPR/NUS Alumni students who read more than 40 units or obtain a 'F' or 'CU' grade and need to repeat/replace. For such cases, the student will need to pay for the additional course by the per-course fee.
 - For August AY2024, August 2025 and August 2026 intakes, all SC and SPR (alumni and non-alumni) will be extended a **40%** tuition fee rebate*. The rebates are non-stackable. For example, students who are both Singapore Citizen and NUS alumni can only enjoy **40%** tuition fee rebate.
 - NUS Alumni (regardless of nationality, AY2024 & AY2025 intakes) are entitled to **20%** tuition fee rebate*.

*Tuition fee rebates for NUS alumni and local students are currently under review. Further updates will be provided in October 2026.

*Students awarded scholarships or study awards will NOT be able to receive any tuition fee rebate.

- Fees paid are non-refundable or transferrable in the event of withdrawal of offer made, non-completion of the programme or switching to other coursework programme by the students.
- Students who wish to read more than 40 units or who failed a course and need to repeat / replace a course will be required to pay additional course fee.
